INFORMATION REQUEST REFERENCE 24-021

Thank you for your information request, received on 5 June 2024. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"I am looking for a communication from London Legacy Development Corporation to the effect of whichever of the following statements is true (with a copy of the relevant amendment to the Byelaw in the case of option 2):

- 1. The land on which the development now known as Chobham Manor stands was outside the area covered by the Queen Elizabeth Olympic Park Byelaws (the "Byelaws") when the Byelaws were adopted by the relevant London Borough; or
- 2. The land on which the development now known as Chobham Manor stands was inside the area covered by the Queen Elizabeth Olympic Park Byelaws (the "Byelaws") when the Byelaws were adopted by the relevant London Borough but it has been removed from the scope of the Byelaws by the attached amendment; or
- 3. The land on which the development now known as Chobham Manor stands is inside the area covered by the Queen Elizabeth Olympic Park Byelaws."

In the understanding of the Legacy Corporation your first statement is correct. Chobham Manor was and remains outside of the area covered by Queen Elizabeth Olympic Park (QEOP) byelaws.

The Byelaws apply to designated areas of QEOP grounds which are set aside as park and open spaces. The physical Park boundary is defined by Park railings, as such it excludes Chobham Manor which is a separate residential estate and not defined for the purpose of these byelaws as pleasure grounds, public walks and open spaces.
